Privacy Statement MINTRISK

Welcome to MINTRISK. MINTRISK is an online calculation tool for vector-borne animal disease risk assessment. MINTRISK was developed by Wageningen Bioveterinary Research (WBVR) and Wageningen Economic Research (WECR). This Website is part of Wageningen University & Research (WUR). With this Privacy Statement, WUR indicates which personal data is collected and for which purpose. In addition, you can read about your rights as a data subject and how to contact us.

What we do with your personal data

To access MINTRISK, login credentials are needed. The data you provide to setup your account are linked to our MINTRISK database and used to save your own risk assessments for later use.

Furthermore, MINTRISK collects certain personal data obtained through the use of our Website. This data is collected for the following purposes:

- 1. Improving our Website; (required) such as IP address, date and time of visit;
- 2. Marketing purposes; (optional) such as your location;
- 3. Social media sharing; (optional) such as YouTube plug-in;

In our Cookie Statement you can read which data the Cookies collect on this Website.

Do we share personal data?

As a general principle, MINTRISK does not disclose your personal data to third parties, unless this is necessary for the functioning of the website and/or the provision of a service. This means that, for example, we try to minimize the use of Cookies and keep the sharing of data with partners to a minimum.

An important exception is the sharing of personal data when it is required under applicable law or in course of any legal proceedings. In that case, MINTRISK must share data with authoritative bodies, for example with law enforcement. This will occur, however, under supervision of a privacy officer.

How long we retain your data

Your login credentials and your personal data (name, affiliation and country) provided when setting up your account are kept for future use of MINTRISK by you. Your personal data will only be kept as long as your MINTRISK account is active. You can ask us to delete your account by using our contact form. Your email address will only be used with your permission.

In our **Cookie Statement** you can read our retention policy regarding Cookies.

How do we protect your personal data?

Obviously, the processing of personal data includes appropriate security measures. Therefore, this Website/App is secured and we also demand that of our partners. WUR's starting point is NEN-EN-ISO/IEC 27002:2017 to make sure that personal data is optimally secured.
